#### III. INFORMATION ITEMS

1. SB24-164 Reporting Update Meeting: Tuesday, March 18 3:00-4:00 pm via Zoom Christina informed Council members that a "town hall" style meeting has been scheduled for next Tuesday, March 18 to provide stakeholders with an update on the reporting requirements for SB24-164. Staff will be providing an overview of this presentation during today's meeting; however, if council members would like to attend next Tuesday, please reach out and staff will provide the calendar invite.

### IV. DISCUSSION/ACTION ITEMS

- 1. 2025 Legislative Session updates
  - SB25-087 Academic Adjustments in Higher Education
     This bill would require institutions of higher education to create and adopt policies and practices to support students with disabilities to self-disclose their disability so that the student can receive an academic adjustment from the institution.
  - SB25-120 Nuclear Workforce Development and Education Program
    This bill would create a nuclear workforce development and education program
    within CDHE to help meet growing workforce demands in the nuclear energy
    sector. The bill also establishes a related grant program to provide grants to IHEs
    for the development or expansion of nuclear engineering degrees, certificate
    programs, or course offerings. The bill also establishes a Colorado nuclear
    workforce development and education council to advise and assist CDHE
    regarding the grant program's implementation and evaluation.
  - HB25-1038 Postsecondary Credit Transfer Website
     This bill would require CDHE, subject to available appropriations (i.e., with gifts, grants, and donations), to develop and maintain a free, publicly accessible online platform to provide current and potential students who are pursuing postsecondary education in Colorado with relevant information about which credits and courses, work-related experiences, and prior learning opportunities are transferable to or between the state's public IHEs.
  - HB25-1041 Student Athlete Name Image or Likeness
     This bill allows an IHE or athletic association to compensate a student athlete for the use of the student athlete's name, image, or likeness.
  - HB25-1186 Work-Based Learning Experiences in Higher Education



This bill creates the WBL consortium pilot program in CDHE. The purpose of the pilot program is to develop and expand the integration of WBL experiences for students enrolled in higher education.

- HB25-1218 Concurrent Enrollment and Higher Education Courses
   This bill has been postponed indefinitely.
- HB25-1221 Emily Griffith Associate of Applied Science Degree
   This bill permits EGTC to offer AAS degrees with approval from the SBCCOE. The
   degree program must include a registered apprenticeship program and certain
   transferable general education courses.
- 2. Continued discussion on SB24-164 (60 minutes):
  - Review CCCS report of the highest enrollment courses
  - Brainstorm and identify courses where "...the number of credit hours differs among institutions and where misalignment occurs between courses..."
     Christina provided an overview of a spreadsheet she created on the implementation status for the GT Pathways directives, noting this spreadsheet will help keep the work of the Council moving forward. Included in the spreadsheet are tabs to track all the directives (e.g., the legislative directive, action required, action status, proposed solution, and notes); highest enrollment courses (data gathered from the report provided by CCCS); GT Pathway courses required for programs/majors; and courses where credit hours are misaligned.

To make this work more manageable, Christina advised Council members to make several assumptions: 1) the focus is on vertical (i.e., two- to four-year) transfer only; 2) the focus is on courses only; and 3) to narrow down the number of courses, the focus is on the top 10 STAAs/DwDs according to data that was pulled from SURDS in AY22. Council members engaged in a brief discussion regarding this data and suggested that receiving institutions review their respective policies regarding misaligned credit. Christina will send out a summary email in the coming days with further information on how Council members should engage with the spreadsheet.

Update on data reporting requirements
 Christina informed Council members that components of the data will be provided by two sources: institutions of higher education and DHE using SURDS (Student Unit Record Data System). All reporting elements are limited to GT Pathways courses. Over the course of several months, the Department worked closely with a cross-functional working group, comprised of volunteer institutional researchers, admissions officers, registrars, and others to define and operationalize key terms (e.g., transfer student, applied, and accepted) to ensure consistency across all institutions.





Using SURDS data, DHE will be reporting on the following: number of students transferring to the IHE; each IHE student is transferring from; average time to complete a bachelor's degree for a transfer student compared to a non-transfer student; average number of credit hours attempted and earned to complete a bachelor's degree for a transfer student compared to a non-transfer student; and average number of term needed to graduate with a bachelor's degree for a transfer student compared to a non-transfer student. IHEs will be required to provide the following data (likely in a spreadsheet/reporting template similar to one used for reporting requirements for Prior Learning Assessment and Students with Disabilities): total number of credit hours both accepted and applied; number of credit hours both accepted and applied, disaggregated by degree program; and number of credit hours both NOT accepted and NOT applied, disaggregated by degree program. DHE staff are continuing to work with both the cross-functional working group and the larger Data Advisory Group (DAG) to finalize the reporting template.

- 3. Prior Learning Assessment policy discussion regarding CLEP Christina informed Council members that an institutional representative emailed a question about the policy around CLEP – they reported their faculty is concerned about accepting CLEP exam scores for academic credit as the exam has no coursework attached to it, meaning there is no guarantee that the exam has sufficiently evaluated a student's understanding of the subject's content and competencies. Council members engaged in a brief discussion around CCHE policy regarding challenge exams and other credit-by-exams. Christina noted <u>current policy</u> allows students to use CLEP to satisfy the test out option; however, she noted she would bring these institutional concerns to the new Senior Director of Academic Pathways and Innovation once they have onboarded.
- 4. New and closed GT Pathways courses After reviewing the sample syllabi, no objections were made regarding the new GT-AH4 courses that were submitted for inclusion to the GT Pathways database. DHE staff will enter these courses to the database this month. These courses will have an effective date for Fall 2025.
