Christina reminded Council members that the institutional (or System) audits of the credit-by-exam matrices are due by April 30. She acknowledged – and thanked – those who have already submitted their updates and asked those who have yet to submit theirs to please do so by the end of the month.

IV. DISCUSSION/ACTION ITEMS

1. Introduction of Brad Griffith, new Senior Director of Academic Pathways and Innovation
Christina introduced Brad Griffith as the new Senior Director of Academic Pathways and Innovation for CDHE and invited him to share information about his background and answer questions from Council members.
2. Proposal to award ECE 1111 course credit for Expanding Quality in Infant Toddler Care (EQIT) certificate (Danen Jobe, CCCS)
Danen Jobe, Director of Academic Affairs for the Colorado Community College System (CCCS), introduced Sierra DiMarco, Education Pathways Program Manager for CCCS. Sierra provided an overview of a credential – the Expanding Quality in Infant Toddler Care (EQIT) credential – that is equivalent to a course in the Early Childhood Education Statewide Transfer Articulation Agreement (STAA). Students who successfully complete the EQIT credential can earn a minimum of 3 credits for ECE 1111 Infant & Toddler Theory and Practice. She informed Council members that efforts to have the EQIT credential approved statewide have been ongoing via the Early Childhood Higher Education Partnership (ECHEP), which is a two- and four-year ECE faculty group.

Council members engaged in a brief discussion regarding the scope of faculty consultation required. Sierra informed Council members that with their support, she can release a vote to the ECHEP group later this month for approval to add EQIT to the ECE STAA. Council members agreed – DHE staff will work with Sierra after the vote for next steps regarding documentation.

- Review/discuss GT Pathways spreadsheet and associated tasks

Christina led Council members in a discussion about the spreadsheet that was created to assist with the GT Pathways directives for SB24-164. In the summary email that was provided to Council members after last month's meeting, Council members were asked to complete three tasks (with the intent to discuss their findings during today's meeting): 1) review the courses listed in the GTP Courses Required For Majors tab and identify courses where students are less likely to receive full credit toward an academic program; 2) review the courses listed in the Credit Hour Misalignment tab and to add any additional courses from their institution (or System) where necessary; and 3) receiving institutions were asked to review their IHE's policy regarding credit hour misalignment for potential harm to students.

Several Council members – from receiving institutions – noted that their IHE's policy regarding credit hour misalignment does not harm transfer students. It was also noted that there are few majors where there are not a lot of elective credit hours available for students, thus providing baccalaureate-degree granting institutions with significant flexibility to help students meet their 120-credit hour degree requirements. This finding suggests that courses where the credits are misaligned (e.g., world languages, mathematics, etc.) can transfer and/or be applied appropriately. However, it was also noted that depending upon the discipline, course, and credit differential, institutional faculty have discretion to determine if learning loss has occurred.

Council members then engaged in a discussion regarding the highly individualized and nuanced experiences of transfer and credit mobility. While improving transparency within GT Pathways is the main directive, Council members wholly agree that the intended audiences (e.g., students, particularly those from underserved communities and backgrounds) have a lack of understanding of this process. Council members largely agreed that GT Pathways, as a system, is working as intended; however, there is a perception problem among students and institutional personnel, which has been made even more clear as Council members have engaged in this review process over the last several months.

Council members expressed interest in discussing potential recommendations around access to information (i.e., better marketing to students) and improved access to academic advising.
